THE SRI LANKAN DIASPORA – THE WAY FORWARD

Sri Lankans have emigrated to different parts of the world over centuries, resulting in the creation of a vast Diaspora straddling the Globe. They are to be found in the United States, Canada, in Europe, in Australia, in UK, in Malaysia and elsewhere in sizeable numbers totalling more than one and a half million. In most cases they have blended into the fabric of the countries in which they find themselves and have actively contributed to the nation-building process in those countries.

In doing so, they have acquired new dimensions, new perceptions and perspectives and even new values. They have undoubtedly encountered problems in the course of their progress. They have proven their potential in those different countries.

This Forum seeks, inter-alia, to review those problems, progress and the potential of the people as experienced by the Diaspora around the Globe. Needless to say, there are lessons to be learnt and to be passed on; experiences to be exchanged and shared, pain and pitfalls to be avoided. And out of all this, how have Sri Lankans emerged? How has their potential been tested? How have they responded to those tests? What does the future hold? How will their future generations chart their course.

Equally importantly, there is a vast pool of knowledge, experience and expertise which can and should be drawn upon through interaction and networking between the different segments of the Diaspora. How is this to be achieved? How is this to be co-ordinated? How is this to be implemented to the best advantage of the Diaspora? These are some of the issues that need to and will be addressed during the Forum.

This Forum, which follows on the previous attempts in Toronto and in Sydney, seeks to examine the many aspects of the Diaspora. The related issues, and the outcome thereof, will affect the direction which the future of the Diaspora will take. Unless the current generation takes steps to co-operate in a positive manner, to network, to promote, to review and to update its academic, commercial and linguistic, cultural and other activities and create a global infrastructure to co-ordinate these activities, there is a distinct possibility that the Diaspora as we know it today will not only diminish but quite possibly disappear in the course of time.

In this context, therefore, various aspects, and in particular, those listed below, need to be explored in considerable depth:

1. Demographic, Geographic, Linguistic
2. Networking

from the point of view of:

1. Women and Youth
3. Educational
4. Commercial
5. Socio-Cultural
6. Professional

Sri Lankans have been and are a resilient people. Their determination to succeed where-ever they are is amply evident. This Forum seeks to harness and galvanize this resilience and determination into a bonding of the Diaspora which would be capable of meeting the challenges of the future.
